

Agreement

This agreement is made by and between The Sovereignty of Usmoelia (or "Usmoelia" in short), based at <https://ugov.wikidot.com>, and Traeist Party of Usmoelia (or "TPU" in short), based at <http://trm.wikidot.com/>. With this agreement, TPU agrees to perform services for Usmoelia for the project tentatively titled 'Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia' on the following terms and conditions.

Services and deadlines

The services that TPU will perform for Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia include:

- Creation of Sovereignty.
- Creation of this contract.
- Creation of MeriToken (MERt).
- Website creation for TPU and Usmoelia.
- Coat of arms, flag, and military coat creation.

Usmoelia needs to approve the work resulting from TPU's services before it is considered complete. Usmoelia will therefore try to continuously and clearly communicate what makes the work complete and will try to approve or disapprove the work resulting from the services as soon as possible. TPU is aware that minor adjustments and fixes to the work are also part of the services.

The deadline for TPU to complete the services is March 7th, 2023. Together, Usmoelia and TPU can agree to set a new deadline or redefine the services to be performed for the existing deadline. When TPU becomes aware that TPU is unable to complete the services on the deadline, TPU will immediately notify Usmoelia. If TPU is unable to complete the services on the deadline and Usmoelia and TPU cannot agree on a new deadline, Usmoelia can decide to no longer use TPU's services.

If Usmoelia does not pay on time, TPU can delay deadlines with as many days as Usmoelia delays the owed payment. If Usmoelia wants TPU to perform services that are not listed above, Usmoelia and TPU can agree to add services to this agreement or sign a new agreement.

Compensation

Before TPU performs any services, TPU will estimate the On creations needed to complete individual tasks of the services and share these estimates with Usmoelia. TPU can begin to work on individual tasks after written approval by Usmoelia. When TPU becomes aware that the On creations needed to perform a task will be higher than estimated, TPU will immediately make a new estimation that in turn needs written approval by Usmoelia. When TPU completes all individual tasks of the services, Usmoelia agrees to pay TPU 10000000 MERt for every On creation spent within the estimate approved by Usmoelia.

All amounts in this agreement exclude taxes such as VAT, GST, or any country's equivalent. TPU will send invoices to receive payment(s) from Usmoelia, after which Usmoelia will make payment Goerli Testnet within 30 days of receiving an invoice. TPU will be responsible for all expenses made while performing the services under this agreement. Because TPU is not an employee of Usmoelia, TPU is not entitled to worker's compensation, retirement, insurance or other benefits afforded to employees of Usmoelia.

Rights to the work

TPU will remain owner of the rights to the work resulting from the services for this agreement, but gives Usmoelia the rights to use and distribute the work as part of Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia Words, Signatures, MERt, Website. These rights include all art, images, designs, audio, videos, code, typography, and text, as they are delivered to Usmoelia, but Usmoelia can make minor changes to the work if

needed. The rights TPU gives to Usmoelia are non-exclusive, meaning that TPU still has the rights to use the work for projects other than Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia without permission from Usmoelia. Usmoelia may not use the work that TPU delivers to Usmoelia in projects other than Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia without written permission from TPU. If Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia is made for another company or if Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia is distributed through another company, publisher, or platform, Usmoelia can give that company the same rights to use and distribute the work as part of Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia.

TPU will make sure that Usmoelia can make full use of the work, which means that TPU will only deliver work that TPU made, or work from others if it comes with a license that allows the work to be included in Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia. If TPU delivers work to Usmoelia that is claimed to infringe the rights of others, then TPU will defend Usmoelia against these claims, and TPU is responsible for all damages Usmoelia may suffer.

Usmoelia agrees to credit TPU in- and outside of Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia following the industry standard. TPU can showcase the work resulting from the services for TPU's portfolio, but if Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia is still unreleased, TPU needs written permission from Usmoelia.

Confidential information

TPU agrees not to disclose or use any confidential information of Usmoelia or Creation of a stable government, economy, and other services for The Sovereignty of Usmoelia without Usmoelia's written permission, both during and after the term of this agreement. Confidential information is defined as information that Usmoelia has not made public.

In case of a disagreement

Both Usmoelia and TPU cannot end the agreement without a good reason. In case of a disagreement, Usmoelia and TPU will do their best to respectfully resolve the disagreement. If Usmoelia and TPU cannot find a solution for their disagreement, and Usmoelia or TPU wants to end the agreement, they need to give a seven day deadline to get to a solution.

If Usmoelia and TPU did their best to resolve the disagreement during these seven days but could not come to a solution, this agreement can be ended, and any rights that Usmoelia already paid for before the disagreement stay with Usmoelia. Usmoelia and TPU can come to an additional agreement about rights that Usmoelia has not yet paid for.

In case of a lasting conflict and Usmoelia and TPU want to go to court, they can only do that in Florida, USA using the laws of Florida, USA.

Signatures

Usmoelia and TPU have both signed every page of this agreement, and each have their own copy of the signed agreement for future reference. This agreement starts on the latest date that Usmoelia or TPU signs.
